GENERAL TERMS AND CONDITIONS

1. Upon acceptance of the entry, the participant is obliged to deliver the entered vehicle at his/her own expense on time to the designated place of the show.
2. Cancellation conditions: in case of timely cancellation of participation you will get back the entry fee paid in the amount of: 100% (cancellation within 30 days before the event), 50% (cancellation within 15 days before the event). In other cases, the deposit will not be refunded and will be used to cover the costs of the event.
3. If you are unable to secure the participation of the vehicle you have entered, please notify it immediately to the organisers.
4. Vehicles on display must be clean and in good technical conditions, and safe drivable.
5. The official vehicle description will be displayed near the vehicle on display. The registration plate will be covered with a label with the show logo for the duration of the show. No other labels, advertisements or promotional materials or banners may not be displayed on the vehicles without the agreement of the organiser.
6. Entrants may place a small picnic table and chairs near the vehicle on display, provided that preferably of a design appropriate to the defined character of the show.
7. If desired, the participant may install a protective rope around the vehicle to protect it from direct contact with spectators.
8. The participant must ensure that no oil or other liquids leak from the vehicle and install a preventive barrier against oil dripping onto the grass under the vehicle (e.g. metal or absorbent pad).
9. The participant provides his/her own protective tarpaulin in case of adverse conditions (rain, hail), which he/she installs on the vehicle in case of danger.
10. The participant takes part in the event at his own responsibility and risk and is liable for any damage caused by him.
11. In case the participant is not the owner of the vehicle, he/she is obliged to secure the owner's consent for participation of the vehicle at the event.
12. The decision of the Concours D'Elegance jury is final and cannot be appealed. The participant is not entitled to make any claims arising from the jury's decisions.
13. By entering, the participant gives consent to the publication of information about the vehicle, including photographs of the vehicle provided by the entrant or taken during the show.
14. By entering, the entrant consents to the processing of personal data in accordance with the relevant laws and regulations (GDPR).
